In my fourth seat, I sat with the construction disputes team in Abu Dhabi. The team works on a lot of high profile, high-value construction disputes team within the UAE and the MENA region more broadly. The team handles disputes relating to a variety of construction projects, including large infrastructure projects and various other forms of property development.

The Abu Dhabi office is smaller than the London office, which gives trainees the opportunity to take on much more responsibility and work more closely with senior associates and partners on matters. Working in a smaller team offers trainees greater exposure to client management and business development activities, which enables you to develop a deeper appreciation of the role of an associate. It also offers increased contact with clients, experts and other lawyers.

As UAE law is often new to secondees, the team offers fantastic training and support to help you get up to speed and as such, you quickly become familiar with operating under another legal system. This all allows you to further develop your transaction management, communication and business development skills.

PLACEMENT PROGRAMME

This is an exciting 12-month programme for second year LLB students to spend their third year on placement at BCLP and take the first steps in building a career in law like no other.

The internship, which is non-rotational, is based across our core departments in the London office and runs in line with the University academic year. To bring you up to speed prior to starting, you'll be invited to join some of our August trainee induction sessions.

BCLP is a place to belong, and as part of the programme we provide a supportive environment for students to learn and grow. First stage

The Emerging Talent team will conduct first-stage interviews via video calls. In addition, applicants will be asked to complete a short drafting and proof-reading exercise.

Second stage

If successful at the first stage of the assessment, candidates will be invited to attend a final stage interview with two fee-earners.


